I am writing to formally request that the Office of the Controller initiate a full audit of the Dream Keeper Initiative (DKI). This would follow informal meetings and conversations around the possibility of such an audit that began during the last calendar year, in 2023, including the most recent discussion on this subject, on July 30, 2024.

The Human Rights Commission respectfully asks that the Office of the Controller provide an audit or a review of all DKI spending across all City & County of San Francisco departments which manage DKI funds, to provide a comprehensive report on the financial condition of DKI funds, operations, and performance through its lifespan.

Our department plans also to request time on the agenda of a future Board of Supervisors meeting to provide an update on DKI. Department staff will also make a presentation to the members of the Human Rights Commission at a special meeting, on Thursday, September 5, 2024, from 5:00pm to 7:00pm at the Main Branch of the Public Library.
