NARRATIVE

On 10/13/2023, at approximately 1054 hours, I spoke to a person over the telephone regarding two incidents that occurred during community meetings in the Richmond District. The person I spoke to requested confidentiality and will be referred to as "The Reportee" for this report. The Reportee is an elected official for the City and County of San Francisco.

The Reportee told me the following in summary:

On 08/09/2023, at approximately 1830 hours, The Reportee was at a community meeting at the Golden Gate Park Senior Center located at 6101 Fulton Street. During the public comment part of the community meeting, a person named "Forrest Liu" was being loud and disruptive. The Reportee asked Forrest Liu to be more calm and respectful during the community meeting. Forrest Liu then responded and said, "Do you want to take this outside?" The Reportee believed that Forrest Liu meant that he wanted to go outside to physically fight the The Reportee. The Reportee then asked another person attending the meeting to ask Forrest Liu if he could calm down. Other people attending the meeting also went outside to alert park rangers regarding Forrest Liu's disturbing behavior. The community meeting then ended without further incident. The Reportee said that there is a video on social media that captured the altercation on 08/09/2023 between Forrest Liu and The Reportee. The Reportee can provide more details on the video at a later date if requested.

On 10/12/2023, at approximately 2000 hours, The Reportee was at a community meeting at the Beach Chalet Brewery and Restaurant located at 1000 Great Highway. During the community meeting, Forrest Liu approached The Reportee and got within five inches of The Reportee's face (face to face) and said, "Don't ever cut into my conversation." The Reportee was not sure what Forrest Liu meant by his comment. The Reportee then left the community meeting without further incident.

It should be noted that The Reportee is an elected official for the City and County of San Francisco and was attending the two community meetings in a professional working capacity. The Reportee is worried regarding the next time The Reportee has to see Forrest Liu. The Reportee believes that Forrest Liu is unreasonable and may want to physically harm The Reportee at future community meetings or events.

The Reportee has contact information for witnesses during the two altercations and could provide this information at a later date if requested.

The Reportee said that Forrest Liu is the Co-Founder and Vice President of Dear Community (<https://www.dearcommunity.org/>).

I provided the Reportee with a case number.

I faxed a copy of this report to SID.

During the event, Yu saw "Forest Liu" verbally engage Supervisor Chan, but Yu did not hear what was said. Yu stated that Supervisor Chan appeared to have "shocked" look on his face. Yu said the interaction was brief and that there was no physical contact between Supervisor Chan and Forest Liu.

I spoke to Ryan Burke on the telephone, who told me the following in summary. On 10/12/2023, Burke attended the community meeting at the Beach Chalet Brewery and Restaurant located at 1000 Great Highway. During the event, an unknown person asked Forest Liu to take down his flag as it was a symbol of hate and bias. Burke witnessed while this was occurring. This made Forest Liu even more loud and confrontive. Supervisor Chan then asked Forest Liu if he could please calm down. Forest Liu then said to Supervisor Chan, "You need to fight". Left to斗地主? Burke said that Forest Liu is known to her from community events to be verbally aggressive and that he gets very close to people when speaking to them.

NARRATIVE

On 01/29/2024, at approximately 1040 hours, I was directed by Captain Canning #269 to contact San Francisco Supervisor Connie Chan regarding making a supplemental report for two past community meeting incidents that occurred on 08/09/2023 and 10/12/2023 in the Richmond District (see initial report 230735443 for further). Chan is an elected official who is a member of the San Francisco Board of Supervisors District 1.

I spoke to Supervisor (R1) Connie Chan over the telephone. Supervisor Chan told me the following in summary: Supervisor Chan had previously requested confidentiality to the initial report that was filed on 10/13/2023, but told me that she no longer wants the initial report to be confidential. Supervisor Chan also told me that she did not want this supplemental report to be confidential either. Supervisor Chan provided me with the contact information for witnesses from the past two altercations during the community meetings. These witnesses included (R2) Julie Pitts, (R3) Brian Quan, (R4) Nick Belloni, (R5) Chet Thong, (R6) Angelina Yu, and (R7) Robyn Burke. Supervisor Chan told me that she did not have video footage of either of the community event incidents from 08/09/2023 or 10/12/2023.

I spoke to Julie Pitta on the telephone who told me the following in summary: On 08/09/2023, Pitta attended the community meeting at the Golden Gate Park Senior Center located at 6101 Fulton Street. During the event, a person named "Forrest Liu" had walked into the meeting and asked Pitta, "How many children have you eaten?" Forrest Liu then got an inch away from Pitta's face and glared at her. Pitta did not engage with Forrest Liu. Forrest Liu then continued to stay at the meeting and acted belligerent and verbally aggressive with other attendees during the meeting.

I spoke to Nick Belloni on the telephone who told me the following in summary: On 10/12/2023, Belloni attended the community event at the Beach Chalet Brewery and Restaurant located at 1000 Great Highway. During the event, Belloni observed an unknown Asian male speaking with Supervisor Chan and Supervisor Chan appeared to have a concerned look on her face.

I called Brian Quan on the telephone, but Quan did not answer and I left a voicemail. At the time of this report, I have not received a call back from Quan.

I called Chet Thong on the telephone, but Thong did not answer and I left a voicemail. At the time of this report, I have not received a call back from Thong.

I spoke to Angelina Yu on the telephone. Yu is a Legislative Aid for Supervisor Chan. Yu told me the following in summary: On 08/09/2023, Yu attended the community meeting at the Golden Gate Park Senior Center located at 6101 Fulton Street. During the event, Yu saw "Forrest Liu" verbally engage Supervisor Chan, but Yu did not hear what was said. Yu then saw that Supervisor Chan appeared to have "shocked" look on her face. Yu said the interaction was verbal only and that there was no physical contact between Supervisor Chan and Forrest Liu.

I spoke to Robyn Burke on the telephone who told me the following in summary: On 10/12/2023, Burke attended the community event at the Beach Chalet Brewery and Restaurant located at 1000 Great Highway. During the event, an unknown person asked "Forrest Liu" to calm down because he was speaking loudly and being disruptive while standing in line. This made Forrest Liu even more loud and disruptive. Supervisor Chan then asked Forrest Liu if he could please calm down. Forrest Liu then said to Supervisor Chan, "You want to fight? Let's go outside." Burke said that Forrest Liu is known to her from community events to be verbally aggressive and that he gets very close to people's faces while speaking to them.
