Good afternoon,

Please find the attached PermitSF Weekly Status Report for your review (November 7, 2025). This version includes all project status and milestone updates. The detailed meeting sessions for this week and next will be incorporated in the finalized version to be shared on Monday for internal distribution on CCSF's SharePoint.

This week reflects a notable improvement in project health, now rated Yellow. The Payment Processor integration, which had been the highest-risk workstream, has made significant progress thanks to strong leadership alignment and collaboration across CCSF, EUNA, and OpenGov. Clear implementation planning, quick turnaround in CCSF business decisions, and unified cross-vendor engagement collectively transformed this deliverable from high risk to low risk.

While the overall outlook is improving, a few areas remain under watch.


- Change management remains a high-priority focus area, requiring sustained attention to ensure consistency across departments and alignment as workloads increase.
- Holiday resource capacity is a shared risk, and upcoming time-off schedules may affect responsiveness and project velocity.
- The MOU for GIS Flag (Parcel Data) is still pending from CCSF and remains the primary open issue delaying data delivery for integration. OpenGov will begin related work immediately upon receipt.

All workflow tracks remain on schedule, and the Validate and Configure phases are now progressing in parallel. November is expected to be a heavy-lift month, requiring tight coordination and forward planning from both teams to sustain progress and mitigate timeline compression. At the current pace and state, no escalation is required. Risks and issues are being actively managed through weekly governance meetings, daily workstream check-ins, and strong cross-team communication.

Next Week's Focus Areas:

- Continue Validate and Configure Phase
- Receive MOU and release of GIS Flag (Parcel Data)
- Continue progress on Payment Integration
- Monitor change management and departmental engagement activities
- Manage holiday resource planning to sustain continuity through November

As outlined in the attached report, the project continues to progress with strong partnership and proactive governance. Key improvements in vendor coordination and leadership engagement have been instrumental in driving momentum and risk reduction.

Delivery	Significant improvement this week with Payment Integration transitioning from high risk to low risk. Strong alignment across CCSF, EUNA, and OpenGov has driven clarity in requirements and implementation planning. Delivery momentum remains steady, with continued focus on managing the pending GIS Flag MOU and maintaining decision cadence through November's heavier workload overlapping the validate and configure phases.				
Schedule	Slight risk persists. Overlapping Validate and Configure phases and the ongoing GIS Flag MOU delay continue to compress timelines. Holiday schedules may add additional pressure; detailed forward planning and prioritization sessions are underway to sustain trajectory toward February go–live.				
Resource/Capacity	Still constrained but improving. Cross-department coordination and proactive planning have helped offset resource challenges. Q4 time-off schedules and availability remain watchpoints, but engagement across teams is strong, and mitigation actions are in place.
