I am writing to inform you that the District is conducting an investigation into allegations of unprofessional conduct against you, including but not limited to misuse of public funds. As part of that inquiry, the District is directing you to attend an interview on Wednesday, October 15, 2025 at 2:00 pm. The interview will happen at the District headquarters at 555 Franklin Street, 3rd Floor, Legal Conference Room. Your attendance at this interview is mandatory. You may bring an attorney, union representative or other representative to the interview if you wish. The meeting will be electronically recorded (if you wish, we will provide you a copy of that recording at the conclusion of the investigation). Christie Herrera and I will be attending on behalf of the District.

In the meantime, I am cautioning you against any action that could impede, impact, or interfere with the investigation. If you need specific guidance regarding this precautionary advice, please speak with Christie Herrera.

District policy strictly forbids retaliation against any person who participates or assists in an investigation of alleged employee misconduct. Thus, I am cautioning you against any statements or actions which might be construed (or misconstrued) as retaliatory against anyone involved in this matter. Obviously, any violation of this no retaliation policy would provide separate grounds for discipline.

Should you have any questions about this matter, please contact your union representative or me. I will be out of the office for the next two days and will have limited access to email.
